Copy Media from a Remote User to NEXIS Workspaces

When connected to Avid NEXIS | Edge, the improved Copy Media function in Media Composer | Enterprise will allow remote users to copy media from their local machines back to a mounted NEXIS workspace. This means that any local media on a user's machine, whether on premise or remote, and regardless of type (high-resolution, proxy or rendered media) can be copied back to the server for use by other editors working on a project.



Copy Media will only work with Avid Media Files and does not support Linked media.

Improvements to Pro Tools Session Export



Pro Tools Session Export is now available for owners of pre-existing perpetual licenses of Media Composer | Ultimate and Media Composer | Enterprise.

The latest version of Media Composer includes updates to the Pro Tools Session export process. In addition to general bug fixes, these changes include the ability to export differences by comparing the entire contents of a bin (not just media files in individual sequences) when the "Ask to Exclude Audio Media from a Previous Sequence" or "Ask to Exclude Video Media from a Previous Sequence" options are selected for the "Copy All Media" export method. Once you click Save and choose a file location, the "Select Sequence" dialog box will appear, and you can select the entire contents of a bin ("All") from the "Exclude Audio and Video Media Referenced from Sequence" dropdown menu. Also, the "Consolidate Media" export method is now able to export by comparing differences using the "Ask to Exclude Audio Media from a Previous Sequence" checkbox as well.

Other updates to Pro Tools Session Export include the ability to include or exclude inactive audio tracks by using the "Include Inactive Audio Tracks" checkbox accordingly, and the option to "Convert non WAV media to BWF", which includes file conversions while copying differences during export.

New "Protect Project Bin" Command Added to Bin Context Menu

When you lock a shared project bin in Media Composer, it prevents other users from making changes to that bin. With the new "Protect Project Bin" command, which is accessed by right-clicking on a shared bin icon in the Bin Container, the bin is made read only for all users, even for the user protecting it. Owners of a locked bin ("Lock Project Bin") see a green bin icon. However, when a user chooses to "Protect Project Bin", it will appear red, even for that user, and will always open as locked. Once the bin is closed, the user who originated the "Protect Project Bin" command can choose to "Unlock Project Bin" using the same context menu.

Right-Click to Add a Folder Within a Folder

In previous versions of Media Composer, folders needed to be created at the root level of the Bin Container before dragging them into a subfolder. Now, simply right-click to add a folder directly within a folder.

New User Profiles and Workspaces for Editors Transitioning from Adobe Premiere Pro

Editors transitioning from Adobe Premiere Pro to Avid Media Composer will find the process easier with the addition of new user profiles and workspaces. When you select "Create User Profile" from the "User Profile" dropdown menu, located at the top of the User Settings window, two default settings now appear: "Media Composer Default" and "Transitioning from Adobe Premiere Pro".



Choose "Media Composer Default", to base your profile on the default settings for the current version of Media Composer, or "Transitioning from Adobe Premiere Pro", which makes the switch easier for those accustomed to particular window layouts and keyboard shortcuts, as well as providing easy access to commonly used editing tools.

Update to Creation Date Column in the Marker Tool


The "Creation Date" column in the Marker Tool now follows the date formatting of the user's operating system, which helps to align dates better and with an appearance that is consistent with a user's region or other preferences. In addition, this column now sorts chronologically instead of alphabetically.

Choice of File or Folder in Relink Dialog

Relink has been improved by allowing the selection of a specific file or an entire folder during the "Locate Media" process. Choosing a folder is a quick method to relink files more easily.

Live Link Support for UME

Live Link is now supported through the Avid Universal Media Engine (UME) and available for use by MOV and MP4 video formats, as well as TIFF, JPEG, and PNG still images (not image sequences). This change removes an additional dependency on Apple QuickTime libraries. With Live Link enabled in the "Link Options" tab of the "Link Settings" window for a particular User, linked video files or static images created in 3rd party applications will automatically relink if they are modified outside of Media Composer.





When using Live Link, the duration, track layout and type of compression for the original file cannot be changed.
