ReadMe for Media Composer® v2022.12.8

Changed in Media Composer v2022.12.8

(Windows) Before installing this release, you must manually uninstall the currently installed version of Media Composer on your system.

Fixed in Media Composer v2022.12.8

The following have been fixed:

- **Bug Number:** MCCET-4900. Length of clip names was different in a bin's Text View and Frame View, which sometimes caused Media Composer to crash when using Baselight.
- **Bug Number:** MCCET-5197. Text entered for the Custom Column name in a bin was limited to 15 characters.
- **Bug Number:** MCCET-5356. Performing Send to Playback with the “Transcode before sending to playback” option enabled in the Transfer Settings window could result in a message that media was offline. After clicking OK to acknowledge the message, media became online.
- **Bug Number:** MCCET-5364. Depending on the selected font size, text was not scaled properly and appeared outside of the bounding box for items in a bin when zoomed out in Frame View.
- **Bug Number:** MCCET-5370. Some AudioSuite effects could not be previewed and caused Media Composer to hang if an EQ3-7 Band effect was used on linked AVCHD media.
- **Bug Number:** MCCET-5394. (Windows) In some instances, PhraseFind AI and ScriptSync AI services were not fully installed on systems with Java (32-bit) present, which caused errors to occur when using these features in Media Composer.

- **Bug Number:** MCCET-5404. In some instances, proxy media created with Telestream Live Capture and EWC (Edit While Capture) was missing a portion of audio at the end of corresponding video files, until the capture was complete. This has been improved.
- **Bug Number:** MCCET-5407. When exporting SubCap text as an Avid DS Caption File (.txt), an extra space was added to the end of each line of text, which was visible after importing the exported file.
- **Bug Number:** MCCET-5433. Importing an ALE file with a Custom Column containing more than 255 characters may have caused Media Composer to report an error or crash.
- **Bug Number:** MCCET-5449. On certain sequences where an audio mixdown was used, Send to Playback may have resulted in an “Unrendered video effects detected after render” message.
- **Bug Number:** MCCET-5459. Enabling Digital Audio Scrub and exiting Trim Mode on a system with AJA I/O hardware installed caused error messages that prevented playback and required users to restart Media Composer.
- **Bug Number:** MCCET-5463. Using Digital Audio Scrub on a system with Blackmagic Design I/O hardware installed caused playback issues.
- **Bug Number:** MCCET-5472. Some interface settings were not working properly for projects stored on a NEXIS workspace.
- **Bug Number:** MCCET-5480. New bins would not save properly after using the AutoSequence feature.
